Azerbaijan Visa Checklist — India Passport (eVisa Required)

EVISA REQUIRED

Tourist - ASAN eVisa (electronic eVisa)

Single-entry eVisa valid for 90 days from issue; permits up to 30 days stay in Azerbaijan.

REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Apply online via the official ASAN eVisa portal (<https://evisa.gov.az>).
- 2 Apply at least 3 working days before travel (standard processing: 3 working days; urgent processing: 3 hours).
- 3 Use the same passport in the eVisa application as the passport you will travel with (if different, the eVisa is invalid).
- 4 Passport must be valid for at least 3 months beyond the eVisa expiry date.
- 5 Print the issued eVisa (it is not affixed to the passport) and present the printed eVisa + passport at the border.
- 6 Each child—even if registered in a parent's passport—requires a separate eVisa application; family applications may cover 2–10 applicants.
- 7 If staying in Azerbaijan more than 10 days, register your place of stay with the State Migration Service within 10 days of arrival.
- 8 Visa on arrival at the border is not available for travellers who are on the official eVisa-eligible countries list—use the eVisa portal.

Visa fee

USD 20 eVisa fee + USD 9 service fee (payable by card). Fees are non-refundable if the visa is denied.

Passport validity

Passport must be valid for at least 3 months beyond the eVisa expiry date.

Photo requirements

Not confirmed on the official eVisa portal for Indian applicants. Azerbaijan general visa law mentions two photos for visa applications, but this is not explicitly stated as an eVisa requirement on the portal.

Financial proof

No eVisa-specific financial requirement stated on the official eVisa portal for Indian applicants.

Travel insurance

Not specified for eVisa on the official portal. General visa-law text mentions a health insurance copy when the inviting party does not cover medical costs, but this is not clearly limited to eVisa applications.

Travel / stay proof

No official arrival card/declaration or additional travel-stay proof requirement found on the eVisa portal; presenting the printed eVisa and passport is the stated entry instruction.

For minors

Each child needs a separate eVisa application even if listed on a parent's passport; family applications can include 2-10 applicants.

Processing / application note

Standard eVisa: issued in 3 working days. Urgent eVisa: issued in 3 hours. Apply at least 3 working days before travel. Fees payable by card; fees non-refundable if visa denied.

Additional notes

The eVisa is electronic (ASAN eVisa) and must be printed. The portal states the eVisa is single-entry. Do not rely on visa-on-arrival—official guidance prohibits obtaining a visa at the border for eVisa-eligible travellers.
