# Czech Republic Visa Checklist — India Passport (Visa Required)

## VISA REQUIRED

Short stay: up to 90 days in any 180-day period (Schengen short-stay rules).

**LAST VERIFIED**  
**19 Sep 2026**

Tourist - Schengen short-stay (Type C) visa — apply at the Czech Republic consulate/embass

## REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Valid passport (issued within the previous 10 years and valid for at least 3 months beyond the date you intend to leave the Schengen area)
- 2 Completed Schengen visa application form
- 3 One recent photo complying with ICAO standards
- 4 Medical travel insurance covering emergency medical care, hospitalisation and repatriation (including in case of death)
- 5 Supporting documents proving purpose of stay (itinerary, bookings, invitation, etc.) and accommodation during your stay
- 6 Evidence of sufficient financial means for the duration of the stay
- 7 Evidence of intention to return to India after the visit (supporting documents as requested by the consulate)
- 8 Appointment/visit to the Czech consulate or authorised visa application centre to lodge the application and provide fingerprints
- 9 Payment of the visa fee (see visa\_fee\_text); additional service-centre charges may apply
- 10 Submit application at least 15 days before travel (and no earlier than 6 months before travel)

### Visa fee

€90 for adults; €45 for children aged 6-12. Reduced/other fees apply for some nationalities (e.g. €35 for applicants from Armenia, Azerbaijan, Belarus; €67.50 for Cabo Verde). An additional fee may apply where visa application centres collect applications

### Passport validity

Passport must be valid for at least 3 months after the date of departure from the Schengen area and should have been issued within the previous 10 years.

### Photo requirements

A photo in compliance with ICAO standards.

### Financial proof

Evidence of sufficient financial means for the duration of the stay (no specific amount given in source).

### Travel insurance

Medical insurance covering emergency medical care, hospitalisation and repatriation (including in the event of death).

### Travel / stay proof

Supporting documents relating to the purpose of your stay (itinerary, bookings, invitation), evidence of accommodation, and evidence of intention to return.

### For minors

Children: reduced visa fee noted for ages 6–12. Fingerprints are collected when submitting the application; exemptions for fingerprints exist for certain specific categories (not detailed in source).

### Processing / application note

Lodge the application at the consulate of the country of main destination (or first point of entry if stays are of equal length). Normal processing time is 15 days; may be extended up to 45 days for detailed examination. You may need to book an appointment.

### Additional notes

For Indian citizens the EU Delegation to India states a visa must be obtained before arrival.
