Denmark Visa Checklist — India Passport (Visa Required)

VISA REQUIRED

Tourist - Schengen short-stay visa (short visit/tourist)

Maximum stay of 90 days in any 180-day period.

23 Sep 2026

REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Apply for a Schengen short-stay visa in advance (no eVisa or visa-on-arrival route for Indian nationals).
- 2 Applications may be submitted up to 180 days before travel (not earlier).
- 3 Apply through the Danish visa application process/VFS (online form) and attend VFS/embassy for biometrics where required.
- 4 Signed cover letter stating purpose of visit, duration, companions, transport and accommodation is required.
- 5 Submit passport (valid at least 3 months beyond intended stay/visa expiry) with at least two blank pages.
- 6 One recent passport-size colour photo (3.5 cm x 4.5 cm), less than 6 months old.
- 7 Proof of sufficient funds: personal bank statements for last 3 months plus evidence of means of subsistence (DKK 350/day if staying with a private host; DKK 500/day if staying in a hotel).
- 8 Travel medical insurance valid for all Schengen countries covering at least EUR 30,000 for the entire trip (including arrival and departure dates).
- 9 Proof of travel and accommodation: return/onward flight reservation and hotel booking or accommodation guarantee covering the full stay.
- 10 Supporting financial/employment documents as applicable (e.g. ITR acknowledgements for last 2 assessment years, payslips, employment contract/leave letter, company registration/GST, sponsor proof, or pension statements).
- 11 Minors (under 18): birth certificate and, depending on arrangements, notarised consent from the other parent(s) plus copies of parents' passports/IDs.
- 12 If documents are missing/incorrect VFS may require them to be provided within 3 days; additional documents or an interview may be requested.

Passport validity

Passport valid at least 3 months beyond intended stay/visa expiry; at least two blank pages required.

Photo requirements

One recent passport-size colour photo, 3.5 cm x 4.5 cm, less than 6 months old.

Financial proof

Personal bank statements for the last 3 months and sufficient means: DKK 350/day if staying with a private host, or DKK 500/day if staying in a hotel; additional financial evidence such as ITR acknowledgements (last 2 assessment years), payslips, employment contract/leave letter, company registration/GST, sponsor proof, or pension statements as applicable.

Travel insurance

Travel medical insurance valid for all Schengen countries covering at least EUR 30,000 and valid for the entire trip including arrival and departure dates.

Travel / stay proof

Cover letter stating purpose/duration/companions/transport/accommodation; return/onward flight reservation; hotel booking or accommodation guarantee covering the full stay.

For minors

For applicants under 18: birth certificate; depending on travel arrangements, notarised consent from the other parent(s); copies of parents' passports/IDs.

Processing / application note

Applications are processed after submission of signed cover letter, passport and biometrics. Apply up to 180 days before travel. Missing or incorrect documents may need to be provided to VFS within 3 days; additional documents or an interview may be requested.

Additional notes

Official Danish sources list India as a country with a visa requirement (Group 3). No Denmark-specific arrival form or eVisa/visa-on-arrival route for tourists was found in the cited official sources.
