Egypt Visa Checklist — India Passport (eVisa Required)

EVISA REQUIRED

Tourist - Online e-Visa (apply via Egypt e-Visa Portal)

REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Apply online via the Egypt e-Visa Portal (<https://visa2egypt.gov.eg>) and create an account.
- 2 Create and submit your e-Visa application at least 7 days before departure.
- 3 Pay the visa fee online by credit/debit card (Visa, MasterCard or other debit cards).
- 4 Tourist visa fees shown on portal: Single-entry \$30; Multiple-entry \$65.
- 5 Print and carry the issued e-Visa printout — it must be presented at the port of entry.
- 6 Passport must be valid for at least 6 months from arrival date.
- 7 Provide travel itinerary and hotel bookings / details about places to visit (listed as entry requirements).
- 8 Each visitor must submit their own e-Visa application in their personal account (parents may apply for their children from the parent account).
- 9 Keep email confirmation: the portal will send a link to download the e-Visa when processed.

Passport validity

Passport must be valid for at least 6 months from arrival date.

Financial proof

Visa fee payable online by credit/debit card; Single-entry \$30, Multiple-entry \$65; visa processing fee is non-refundable.

Travel / stay proof

e-Visa printout (must be presented at port of entry); travel itinerary; hotel bookings/details about places to visit.

For minors

Parents can apply for their children from the parents' account; each visitor otherwise must submit own application.

Processing / application note

Apply at least 7 days before departure. After payment and submission, you will receive an email with application status and a link to download the e-Visa once processed.
