Georgia Visa Checklist — India Passport (eVisa Required)

EVISA REQUIRED

Short-stay visits only (less than 90 days)

LAST VERIFIED

19 Sep 2026

Tourist - e-Visa (online via evisa.gov.ge / Ministry of Foreign Affairs of Georgia e-Visa)

REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Valid passport (see passport validity requirement below) — scan the passport in a single PDF for the application
- 2 Recent photo (to be uploaded with the application)
- 3 Document proving purpose of travel (e.g., itinerary, invitation, booking)
- 4 Proof of accommodation / hotel reservation
- 5 Round-trip flight ticket reservation
- 6 Travel and health insurance covering the entire period of stay (must be presented at border if requested)
- 7 Document proving sufficient financial means (e.g., bank statement)
- 8 Complete e-Visa application on evisa.gov.ge and pay the consular fee online (must apply from outside Georgia)
- 9 After submitting the e-Visa application, complete the DuVerify step within 24 hours (additional USD 15 per applicant)
- 10 Be able to present all required original documents at the Georgian state border (incorrect information may invalidate e-Visa and lead to refusal of entry)
- 11 Comply with COVID-related entry rules on the portal: vaccinated travelers present proof of full vaccination; non-vaccinated present a PCR negative result within 72 hours in Georgian, English, or Russian; children under 10 exempt from PCR requirement

Visa fee

Payment of consular fee is required during e-Visa application (amount not stated on the pages). An additional DuVerify fee of 15 USD per applicant is explicitly required after the e-Visa application.

Passport validity

Passport validity should extend at least three months after the validity of the requested Georgian visa

Photo requirements

Photo required (portal instructs to upload a photo; no detailed dimensions/specs provided on the pages)

Financial proof

Document proving sufficient financial means such as a bank statement (portal lists 'Proof of financial means' / 'Bank Statement')

Travel insurance

Travel and health insurance covering the whole period of stay; portal notes travel/health insurance is required and must be presented at border if requested (eInsurance/eCover options referenced)

Travel / stay proof

Round-trip (two-way) ticket reservation

Processing / application note

e-Visa application consists of two mandatory steps: 1) complete e-Visa application and pay the consular fee online; 2) complete the DuVerify application within 24 hours of step 1 (DuVerify fee USD 15 per applicant). You must apply only while outside Georgia.

Additional notes

The e-Visa grants the same right to enter Georgian territory as a sticker visa. The Ministry is not responsible for private companies offering submission services. Electronic visas issued by the State of Israel are not accepted at the Georgian border (a physical Israel visa stamp is required when applicable).
