Hong Kong Entry Checklist — India Passport (Visa Exempt)

VISA EXEMPT

Up to 14 days per visit

Tourist - Pre-arrival registration (online) required for visa-free visit

ENTRY REQUIREMENTS / TRAVEL CHECKLIST

- 1 Complete Pre-arrival Registration (PAR) online via the designated GovHK service before travel (required for Indian nationals unless in direct air transit and not leaving the airport transit area).
- 2 Ensure your Indian passport used for PAR is valid for at least 6 months at time of application/entry.
- 3 Print the "Notification Slip for Pre-arrival Registration for Indian Nationals" on a blank A4 white paper, sign it, and carry it together with the same Indian passport used for the registration when boarding and on arrival.
- 4 Information entered in PAR must exactly match the passport data and you must use the same passport for travel; if passport is renewed or personal particulars change you must re-apply.
- 5 Bring onward or return ticket (unless in transit to Chinese Mainland or the Macao SAR) and demonstrate adequate funds to cover the duration of your stay without working.
- 6 PAR result is provided instantly by the online system; successful registration is valid for six months and allows multiple visits during that validity, each visit up to 14 days.
- 7 If PAR cannot be completed, apply for an entry visa from the HKSAR Immigration Department before travel (Chinese diplomatic/consular missions do not accept visit visa applications from Indian nationals).
- 8 At arrival you remain subject to immigration control; entry is not guaranteed. If admitted, you will be issued a landing slip stating conditions and limit of stay.
- 9 Visitors are not permitted to take up employment (paid or unpaid), establish or join in any business, or study in Hong Kong as a visitor.
- 10 For travellers under 16, a parent or legal guardian must check the PAR data and sign the notification slip.

Visa fee

Pre-arrival registration: free of charge

Passport validity

Indian passport must be valid for at least 6 months

Financial proof

Must have adequate funds to cover the duration of stay without working

Travel / stay proof

Onward or return ticket required (unless in direct transit to Chinese Mainland or the Macao SAR); must present printed signed PAR notification slip plus the same passport used for registration before boarding and on arrival

For minors

For registrants under 16, a parent or legal guardian must check the inputted data and sign the notification slip; parent/guardian must use the same passport linked to the registration when travelling

Processing / application note

PAR is processed instantly online; successful registration is valid for 6 months and must be printed on A4 white paper and signed. If registration cannot be completed, a visit visa must be applied to the Immigration Department before travel.

Additional notes

Indian nationals may visit Hong Kong visa-free for up to 14 days only after completing PAR. Holders of Indian diplomatic or official passports, holders of a valid HKSAR Travel Pass, those enrolled for e-Channel frequent visitor service, or those with a valid entry visa are not required to complete PAR. Entry remains subject to normal immigration requirements and can be refused.
