Iceland Visa Checklist — India Passport (Visa Required)

VISA REQUIRED

Up to 90 days in any 180-day period

LAST VERIFIED

21 Sep 2026

Tourist - Schengen short-stay visa (Type C) — apply via VFS Global / Iceland embassy in In

REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Schengen short-stay visa application lodged via VFS Global (apply in country of legal residence; apply to the Schengen state that is main destination or first entry if equal duration)
- 2 Passport valid for at least 3 months after intended departure from the Schengen area, issued within the last 10 years, with at least 2 blank pages
- 3 One passport photograph meeting Iceland/Schengen specifications (New Delhi FAQ: one photograph required)
- 4 Travel medical insurance valid for entire stay with minimum coverage EUR 30,000
- 5 Proof of sufficient means: reference amounts listed as ISK 8,000 per day (or ISK 4,000 per day if a third party bears costs / homestay)
- 6 Return or round-trip flight reservation (and onward Schengen travel proof if travelling to multiple Schengen countries)
- 7 Proof of accommodation (hotel reservation, rental agreement, campus residence, or host/private accommodation proof)
- 8 If hosted/sponsored: invitation letter and host's bank statement proving ability to support the visitor
- 9 Biometrics: first-time applicants must appear in person for fingerprint/photo capture (VIS system)
- 10 Parental authority/legal guardian details and signature required on application for minors
- 11 Apply no earlier than 6 months before travel and no later than 15 calendar days before travel
- 12 Pay applicable visa fee (EUR 90 standard; children 6-12 EUR 45; under 6 exempt) — follow VFS/embassy payment instructions
- 13 Submit complete supporting documents (official guidance warns incomplete applications may be accepted only at applicant's risk and can cause delays or refusal)

Visa fee

Standard fee EUR 90; children 6-12 pay EUR 45; children under 6 exempt

Passport validity

Valid at least 3 months after intended departure from Schengen area; issued within past 10 years; at least 2 blank pages

Photo requirements

One passport photograph per Iceland/Schengen specifications (New Delhi FAQ states one photograph required)

Financial proof

Reference amounts: ISK 8,000 per day (or ISK 4,000 per day if a third party bears costs / homestay); border officers may ask for proof of means

Travel insurance

Travel medical insurance covering entire stay with minimum coverage EUR 30,000

Travel / stay proof

Return/round-trip flight reservation; onward Schengen travel proof may be required for multi-country trips

For minors

Application must include parental authority/legal guardian details and signature for minors

Processing / application note

Apply via VFS Global to the Iceland embassy/representation in India; first-time applicants must attend in person for biometrics; apply between 6 months and no later than 15 calendar days before travel; incomplete applications can lead to delays or refusal

Additional notes

No verified Iceland government requirement for a special arrival/passenger locator form was found in the cited sources; visa processing is handled at Iceland embassies in India and applications are lodged through VFS Global
