ENTRY REQUIREMENTS / TRAVEL CHECKLIST

- 1 Passport: valid ordinary Indian passport (official sources do not specify a minimum remaining validity for this visa-free entry).
- 2 No visa or e-visa required for tourist travel up to 14 days (visa-free regime applies).
- 3 No visa-on-arrival required.
- 4 No separate visa application, photos, proof of funds, travel/health insurance, or hotel booking are stated as required for this 14-day visa-free entry.
- 5 No arrival registration is required for stays of 14 days (registration of foreign citizens for stays up to 30 days was cancelled).
- 6 If travelling on a diplomatic or service passport, note the MFA table shows different terms (30 days) — this checklist applies to ordinary passports.

Passport validity

Official MFA page does not list a special minimum validity for the visa-free Indian tourist entry rule.

Photo requirements

None stated for visa-free tourist entry (no separate visa application required).

Financial proof

None stated for visa-free tourist entry (no proof of funds required in official source).

Travel insurance

None stated for visa-free tourist entry (no travel/health insurance requirement listed).

Travel / stay proof

No special arrival form or registration required for a 14-day tourist stay (registration for stays up to 30 days was cancelled).

For minors

No official minor-specific entry rule for Indian tourists was found in the cited government sources (not verified).

Additional notes
