Mauritius Visa Checklist — India Passport (Visa on Arrival)

VISA ON ARRIVAL

Tourist - Visa on Arrival

May be granted on arrival for a maximum
period of 60 days

LAST VERIFIED

29 Sep 2026

REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Passport valid for at least 6 months beyond the date of stay
- 2 Valid return or onward ticket
- 3 Sufficient funds to meet costs of stay (normally US\$100 per day or equivalent to cover expenses other than board, as stated in official guidance)
- 4 Confirmed hotel booking OR evidence of local sponsorship (if sponsored, sponsor details such as name, address, telephone number. National Identity Card and utility bill)
- 5 Not engage in any gainful (paid) activity during the stay
- 6 Fill in and submit the Digital or Printed All-In-One Travel Form issued by the Ministry of Health and Wellness and hand it over at Health Counters on arrival
- 7 Vaccination certificate only required if coming directly from an area infected with cholera or yellow fever (as published in WHO Weekly Epidemiological Record)
- 8 Be eligible to re-enter country of origin or residence
- 9 Admission is subject to final decision by Mauritius Immigration on arrival

Passport validity

Passport must be valid for at least 6 months beyond the date of stay

Photo requirements

Two recent passport-size photographs are required when applying for a visa prior to travel (as per visa application guidance)

Financial proof

Sufficient funds; guidance states normally US\$100 per day (or equivalent) to cover expenses other than board

Travel / stay proof

Valid return or onward ticket; confirmed hotel booking or local sponsorship evidence

For minors

Children travelling on a parent's passport need not complete a separate visa application form (per Passport & Immigration Office guidance)
