Mexico Visa Checklist — India Passport (Visa Required)

VISA REQUIRED

Up to 180 days (visitor visa for tourism)

LAST VERIFIED

29 Sep 2026

Tourist - Consular visa (apply at Mexican Embassy/Consulate)

REQUIRED DOCUMENTS / VISA CHECKLIST

- 1 Valid ordinary passport (see passport validity below); original + photocopy of first and last page
- 2 Completed Mexico visa application form (consular)
- 3 One recent passport-size photo (4.5 cm x 3.5 cm; white background; face should occupy ~80%; no glasses)
- 4 Proof of solvency/supporting documents: employment letter, recent payslips, bank statements, cover letter (consulate may request additional documents case-by-case)
- 5 Proof of legal stay in India if the applicant is not an Indian national (original + copy)
- 6 Hotel bookings and flight reservations are NOT listed as a requirement by the Embassy (may still be requested by consulate in some cases)
- 7 If visa approved, present Forma Migratoria Múltiple (FMM) on entry (FMM validity up to 180 days; presented along with passport and visa)
- 8 Applicants from India must apply at the Mexican Embassy/Consulate; no official visa-on-arrival for Indian passport holders
- 9 If you hold a valid U.S., Canada, Japan, U.K. or Schengen visa or permanent residence from those jurisdictions, you may enter Mexico without a Mexican visa (up to 180 days) — otherwise apply for a consular visa

Passport validity

Passport valid for at least 6 months from date of travel

Photo requirements

One recent passport-size photo 4.5 cm x 3.5 cm; white background; face should cover ~80% of the photo; no glasses

Financial proof

Salary slips, bank statements and other proof of solvency as listed by the consulate; consular section may request additional financial proof (hotel/flight bookings are not required per Embassy guidance)

Travel insurance

No official Mexican government source in the provided material requires travel insurance for this visa category

Travel / stay proof

Complete/present Forma Migratoria Múltiple (FMM) on arrival (present with passport and visa); FMM shown as max 180 days, one entry (land-entry page noted)
