Nepal Entry Checklist — India Passport (Visa Exempt)

VISA EXEMPT

Tourist

No separate official stay-limit rule was found for visa-exempt Indian tourists. (General tourist-visa guidance for other nationalities states tourist visas may be extended up to a combined 150 days per visa year.)

ENTRY REQUIREMENTS / TRAVEL CHECKLIST

- 1 No visa required for Indian nationals—visa-exempt entry to Nepal for tourism.
- 2 Preferred entry document: valid Indian passport (recommended, especially for air travel).
- 3 If no passport available: Indian voter (election) card is accepted as an entry document.
- 4 Minors without a passport: birth registration certificate may be used for permission to enter.
- 5 Other accepted ID listed by tourism/immigration: election card, PAN card, driving licence, ration card with photo/age proof for older persons. school ID for children under 18.
- 6 Aadhaar/UID is NOT acceptable as a travel document for entry to Nepal.
- 7 No special arrival/online form specifically for Indian tourists was identified in the official sources.
- 8 Carry ID at entry/exit; arriving by air, travellers are encouraged to travel with a passport for quicker processing.

Passport validity

No official 6-month passport-validity rule for visa-exempt Indian travellers was found. (The 6-month validity statement appears on eVisa guidance for eVisa applicants, not as a separate rule for visa-exempt Indians.)

Photo requirements

No official requirement for passport-size photos for visa-exempt Indian entrants was found in the cited government sources (photo requirements are mentioned in the context of visa/eVisa processing for other nationalities).

Financial proof

No official proof-of-funds requirement for visa-exempt Indian tourists was found in the cited government sources.

Travel insurance

No official travel-insurance requirement for visa-exempt Indian tourists was found in the cited government sources.

Travel / stay proof

No official hotel/itinerary/proof-of-stay requirement for visa-exempt Indian tourists was found in the cited government sources.

For minors

Minors may use a birth registration certificate if they do not have a passport; school ID acceptable for children under 18 (per tourism/immigration FAQ).

Processing / application note

Because Indian nationals are visa-exempt for tourism, there is no tourist-visa application or visa fee to submit for ordinary tourist entry. Standard arrival/visa forms and eVisa processes do not apply to the visa-exempt Indian case.
